**AS A PARENT/GUARDIAN/CUSTODIAN:**

- I have read the Drug Testing Policy and understand the responsibilities of my son/daughter/ward as a participant in athletics in the Evergreen Local School District.

All drug test results are considered confidential information and will be handled accordingly. Those persons having access to test results, as set forth by this policy, must sign a Confidentiality Statement (Appendix A).

## 9. CONSENT TO PERFORM URINALYSIS FOR DRUG TESTING

We hereby consent to allow the student named on the front of this form to undergo urinalysis testing for the presence of illicit drugs or banned substances in accordance with the Policy and Procedure for Random Urine Drug Testing of the Evergreen Local School District Students as approved by the Evergreen Local School District Board of Education

We understand that the collection process will be overseen by a qualified vendor whose employees have had criminal background checks, will present no danger to the student, and are qualified to undertake the activities associated with this test.

We understand that any urine samples will be sent only to a certified medical laboratory for actual testing, and that the samples will be coded to provide confidentiality.

We hereby give our consent to the medical vendor selected by the Evergreen Local School District, their laboratory, doctors, employees, or agents, together with any clinic, hospital, or laboratory designated by the selected medical vendor to perform urinalysis testing for the detection of illicit drugs or banned substances.

We further give permission to the medical vendor selected by the Evergreen Local School District, its doctors, employees, or agents, to release all results of these tests to the Medical Review Officer (MRO) working for the medical vendor. We understand these results will be forwarded to the Designated Official and will also be made available to us.

We understand that consent pursuant to this Informed Consent Agreement will be effective for all athletic activities, in which this student might participate during the current school year.

We hereby release the Evergreen Local School District Board of Education, the vendor testing service, and its employees from any legal responsibility or liability for the release of such information and records.
